PUBLIC ACCESS AND BOAT LAUNCH

At last count, 9 persons had contacted Mark Semple to express their interest in public launch facilities - in response to the notice in newsletter 1983-3. The Association has been working on the matter over the winter, and this is the situation to date:

There is no Crown land available for the purpose; Ministry of Natural Resources permission will be a requirement, when and if a site is identified; No site will be ready by June of this year; Additional consultations are being held with the

Townships and provincial agencies.

In the meantime, we can only advise residents who need launch facilities to make private arrangements as best they can for this season, in hopes that something may be available by the Fall. (see late news on page 4.)

WATER FILTERS - DO THEY WORK?

A review of the available information from Health and Welfare Canada indicates that water filters consisting of ceramic cartridges impregnated with metallic silver (Sterasyl or sterasyl type) do an adequate job of removing coliform amd total plate count bacteria at their rated flows. They are effective and suitable for use at the level of bacteria found in Otty Lake. These filters will not remove all viruses, but they are not considered a hazard in this regard. Filters containing activated carbon alone are not recommended and should not be used.

FISH KILL

In mid-April residents of Areas 1 and 9 discovered large numbers of small dead fish along the shore. The Ministry of Natural Resources investigated and advised that the fish are alewives. This species is known to be subject to massive die-off, so they do not attribute it to any toxic condition in the lake. This may be a winter kill - that is to say a suffocation of fish due to ice having penetrated so deeply as to drive out the oxygen required by the fish. But this seems unlikely, as no other species appears to have been affected. So far, no other explanation has been offered.

ANNUAL MEETING

As fixed by our constitution, the AGM takes place on the second Saturday in July. This is your chance to ask questions or raise objections to Association attitudes. It is also your chance to offer to serve Otty Lake. Right now we could use a Secretary, an editor for the newsletters, and an Information Officer.

BUILDING PERMITS


Every year we give members this reminder, just so that no one will forget the rules that are in place for the protection of us all. They are not onerous, and so for this reason we have all found it easy to comply.

Right?
The main items to remember are these:
 To construct any building, dock,
shed, deck, cabin or other structure,
call the Building Inspector to make

shed, deck, cabin or other structure, call the Building Inspector to make sure that what you have in mind is legal. Only if the value of the structure is expected to be more than \$2,500. (the value, not the cost) will apermit be required; and the cost of a permit is modest.

In North Burgess, the Building Inspector is Jim Connell, whose phone is 267 4605.

In North Elmsley, the Building Inspector is George Coutts, phone 283 4461.



BRUSH CLEARING UNDER HYDRO LINES

Cottagers and year-round residents of Otty Lake are reminded that, if they wish to do so, they may perform the clearing of brush under the hydro lines instead of waiting for Hydro to do it for them.

This reminder is being given at this time because Hydro is sending notices in some areas, indicating their intention to spray and/or cut brush in the near future.

The Hydro right-of-way is normally 30' wide, and brush there must be kept below 6' high. Property owners wishing to do the work themselves must file an appropriate form - which is available from the Area Counsellors or from Hydro - and leave it with the Perth office of Hydro, agreeing to meet these conditions.

BRUSH BURNING

Speaking of brush, you should bear in mind the local rules about burning brush and leaves. After April 1st in North Burgess and North Elmsley no one may burn an open fire except by permit. Permits may be obtained by contacting Norman Ferrier at 267 1265 (Nor. Burgess) or Gerrit Leeflang at 267 3049 (Nor. Elmsley)
